Kimberley W. Scott has been prosecutor with San Diego County District Attorney's Office for approximately 20 years. For the past 11 years she has been in the Insurance Fraud Division, and, for the past 6 years, she has been the Team Leader for the Disability and Healthcare Insurance Fraud team which prosecutes Medical Insurance Fraud, Disability Fraud and Prescription Fraud throughout San Diego County.

In the Insurance Fraud arena, she has also prosecuted cases involving Auto Insurance Fraud, Workers' Compensation Fraud, Wage Theft and Embezzlement. In 2016. Kim and her co-counsel obtained what is believed to be the first jury conviction in California for Wage Theft about which Kim has a published article with the National District Attornevs Association.

Kim has presented trainings for the California District Attorneys Association, National Healthcare Anti-Fraud Association and she also presented at the National Association of Drug Diversion Investigators California Chapter Training in 2019 and 2023. Kim received her Juris Doctor from California Western School of Law, San Diego, and her B.A. in Mathematics from California State University, Long Beach.

SAVE THE DATE! LOBBY DAYS 2024 WILL BE HELD ON TUESDAY AND WEDNESDAY, APRIL 2nd & 3rd

We encourage all AAUW California members to participate in this act of advocacy that is essential for achievement of our legislative priorities. In addition to our members, we plan to invite college students to join the event. Their participation will enable us to reach more legislative offices, and we hope that this introduction to our organization will inspire these advocacy-minded young people who share our values to join AAUW.

We are planning a hybrid event with meetings scheduled virtually over Zoom as well as in person at the Capitol. Members who live in and around Sacramento will have the option to participate in person. Legislative offices are willing to meet virtually or in person, and the virtual option makes it easier for AAUW members around the state to participate.

Training materials on the bills and the event will be posted on the state website in mid-March, and a mandatory training webinar will be held on March 25th.

Lobby Days provide a wonderful opportunity to meet with your legislators and advocate for legislation to promote gender equity and improve the lives of women and girls. We hope that you will join us in this important activity to advance our values.


FUND

The donations so far this year to the AAUW FUND have reached \$231,804.00. Our branch donations have reached \$2,240.00...THANK YOU! Donations can still be made until December 31st. Harvard University economics professor, Claudia Goldin PHD, was recently rewarded the Nobel Prize in economic sciences for her extensive work on gender differences in earnings. Closing the gender pay gap is stubborn. For example, Native American women are earning only 55 cents per dollar paid to the average white man. AAUW stood in support of students devastatingly impacted by Trump Title IX rule which undermined civil rights protection for student survivors. New Title IX rules will be finalized in March.

EQUAL RIGHTS AMENDMENT LONG OVERDUE! The U.S. is the only modern democracy that does not include sex equality in its constitution. This amendment will be introduced again in Congress this month. It has been 100 years attempting to pass this amendment. AAUW FUND has been supporting an active advocate for the passage of this amendment!

In 2023 there are 34 inspiring California women studying with help from AAUW FUND's Fellowships and Grants. What incredible topics are these women studying? You can view their brief synopsis at AAUW.ca.org.
