PUBLIC POLICY

There are 3 Bills that have been placed on AAUW California's 2024 Legislative Agenda. Through a day and a half of discussions, the policy committee reviewed 67 bills, considering their merits and potential costs. The three selected are:

AB 2843 "Health Care Coverage for Rape and Sexual Assault Survivors.

AB 2326 "Title IX Oversight and Compliance Act" and AB 2099, "Protecting Reproductive Health Clinics".

***AB 2843 i s sponsored by AAUW California and falls under two of our Public Policy Priorities, "Social and Racial Justice for All Members of Society" and "Economic Security for All Women". The bill eliminates cost-sharing, including deductibles, from being imposed on any rape survivor seeking medical care following a rape. Insurers will be required to cover the cost of medical care with no copay. AB 2843 ensures that those individuals who wish to report a rape and file charges will have the benefit of a rape kit test and forensic exam to provide evidence to secure more convictions for acts of sexual violence. In addition, they can receive the care they need following a traumatic sexual attack.

***Our second "A" priority bill, AB 2326 "Title IX Oversight and Compliance Act" is also sponsored by AAUW California. This bill falls under our Public Policy Priorities pillar "Equal Access to Quality Education for All Students" and champions something that AAUW California has long supported: Title IX enforcement. AB 2326 requires the Chancellors of the Community Colleges and State Universities and the President of the University of California to provide an annual report of their compliance with Title IX, with the report to be presented publicly and orally to the Senate and Assembly Budget Subcommittees on Higher Education Finance, a move to hold the systems, and their leaders, more publicly accountable.

***AB 2099, "Protecting Reproductive Health Clinics". This bill falls under our Public Policy Priorities pillar "Social and Racial Justice for All Members of Society". The bill makes it possible for the D.A. to file a felony charge for sharing personal information or images of individuals such as reproductive health care providers or patients, with the intent of causing harm or violence against them, if the posting and subsequent action results in bodily injury. With violence against abortion providers continuing to rise following the reversal of Roe, the protection of providers and patients is now.

AAUW National Elections 2024

Beginning April 3rd and continuing until May 15, we are being asked to cast our vote on an amendment to the national bylaws recommended by the AAUW Board of Directors and AAUW Governance Committee that would open membership to any individual who supports AAUW's important mission of advancing equity for women and girls.
